PERMISSION SLIP

RULES AND REGULATIONS

Because we have a pastoral responsibility before God to promote a lifestyle which is pleasing to Him and because of our concern for the well being of our youth and their righteous testimony within the church and to the world, we have adopted the following policies of all youth related ministries:

All youth are required to stay with the youth group at all times unless under the consent of Pastor Jake. All youth must refrain from the use of tobacco, alcoholic beverages and drugs during their time with us. No youth is allowed to have weapons of any kind. All youth are required to treat leaders with respect. All youth must refrain from physical display of affection.
